The following responds to questions received on the solicitation reference above:

Question 1:	We would like to know it there is any bridge, concrete barrier or walls, cleaning and painting, for Invitation # 0-00818?
Response 1:	No
Question 2:	Please provide roadway plans so we can quantify the work area accurately. It is not possible to get an accurate measurement using the satellite views.
Response 2:	It is the Contractor's responsibility to determine all quantities for which the bid will be based on but THEA and their GEC will provide roadway plans of the REL.
Question 3:	Should the asphalt mix be FC9.5 TLC, PG76-22 PMA instead of SP9.5 as shown in the Summary of Work?
Response 3:	Yes, it should be FC9.5 TLC, PG76-22.
Question 4:	What is the correct contract time? 60 days as well as 90 days is shown in the bidding document.
Response 4:	The correct contract time is 60 days. Including cure times.
Question 5:	The work hours are shown as 7:00pm – 5:00am. Is it possible to close all of reversible lanes during this time period?
Response 5:	Yes.
Question 6:	The summary of work states that no shoulder work is anticipated. Please confirm that there will be no shoulder milling or resurfacing.

Response 6:	There is no shoulder work.
Question 7:	Do we need to trim overlap on shoulder?
Response 7:	Yes.
Question 8:	Are the gore areas included in the scope of work?
Response 8:	The gore areas will not be milled and resurfaced. Any damage to the existing striping will be repaired/replaced by the Contractor.
Question 9:	Is a bid bond required for this project?
Response 9:	No.
Question 10:	Does THEA has a website or listing of SBE/WMBE/DBE. As long as we solicit and follow-up in our invitation to bid that we send out, we will be incompliance to bid this proposal?
Response 10:	THEA does not have a listing. Yes, as long as the Contractor follow-up compliance will be met.
Question 11:	What is the estimated value on the project and to when the actual construction will begin?

Response 12:	\$2.1 million

Response 14:	Yes. No striping plans, just match what is currently there.

Response 15:	All work will be performed at night.

Response 16:	Yes. Existing is FC 5.
Question 17:	Is some FC 9.5? Also, are there any slip ramps?
Response 17:	Slip ramps are to be milled and resurfaced in the same manner an like material as the main line REL.
