To all prospective respondents:

The following responds to questions received on the solicitation reference above:

Question 1:	Will the Authority issue a list of "interested vendors" during the week of the due date for questions asked to facilitate identification of partnering/teaming opportunities?
Response 1:	Teams are encouraged to submit their areas of expertise related to any of the requirements provided, and are not expected to meet every requirement. Multiple teams will be selected to provide diversity and breadth of capabilities. A list of "interested vendors" from Demandstar is attached as part of this Letter of Clarification.
Question 2:	Is the vendor team required to support all requirements of the LOI, or can it support individual or separate requirements which are delineated in the LOI?
Response 2:	If a vendor team cannot meet the whole Scope of Services they can be selected for having an area of excellence in one of the areas. Therefore, if your team excels in one or more of the areas you are encouraged to submit.
Question 3:	Does the following statement mean that all key personnel bid be 100% available at all times to the project? For example, one could actively participate with 50% of their billable hours in our assessment.

Question 4:	Can you provide the names of Evaluation Committee members for the below opportunities?
