Question 1:	What (year) are the applicable Lighting Specifications?
Response 1:	<b>The FDOT January 2020 specifications will govern during construction with TSPs as applicable.</b>
Question 2:	Are there any Technical Special Provisions with regards to the installation and commissioning of the programmable digital control system?
Response 2:	<b>Shop drawing reviews will be required for all digital control system elements.</b> <b>No TSP will be necessary, the intent is for the contractor to provide the digital control system and the consultant team will program and install the unit.</b>
Question 3:	What are the contractor's permitted Lane Closures/Restrictions?
Response 3:	<b>Lane closures will only be allowed at the following times: MONDAY-THURSDAY between the hours of 7pm and 5am, MON-FRIDAY between the hours of 9am and 3pm, and between the hours of 7am SATURDAY and 5am MONDAY.</b>
Question 4:	What are the contractor's permitted hours of operation?
Response 4:	<b>The contractor is permitted to work at any time.</b>
